

# Valley Christian Schools reenrollment 2021-2022

## Tuition Information and Re-Enrollment Financial Policies

### 2021/22 Tuition and Re-Enrollment Fees: 1-5 (Leigh Campus) and 6-12 (Skyway Campus)

The total cost to attend Valley Christian Schools in 2021/22 will rise by a total of 5.50% in grades 4-12, and 4.50% in grades 1-3. Of this amount, to ensure your child's enrollment, non-refundable deposits will be due as follows: If you enroll by February 28, 2021, it is \$225 for the elementary school (1-5), and \$800 for grades 6-12. If you enroll on March 1, 2021, or later, it is \$500 for the elementary school (1-5), and \$1,200 for grades 6-12. The school is anticipated to be AT CAPACITY again next year. Last year our re-enrollment rate exceeded 99%.

### FOR JUNIOR HIGH AND HIGH SCHOOL (Grades 6-12)

To ensure your child is enrolled in the junior high or high school, pay the non-refundable enrollment fee of \$800 anytime from February 1, 2021, to midnight, February 28, 2021. If the re-enrollment fee has not been received during February, on March 1, 2021, your child's reserved seat will be released and he/she will be placed on a waiting list. An enrollment fee of \$1,200 would then be due in order to enroll your child.

### FOR ELEMENTARY SCHOOL (Grades 1-5)

To ensure your child is enrolled in the elementary school, pay the non-refundable enrollment fee of \$225 anytime from February 1, 2021, to midnight, February 28, 2021. If the re-enrollment fee has not been received during February, on March 1, 2021, your child's reserved seat will be released and he/she will be placed on a waiting list. An enrollment fee of \$500 would then be due in order to enroll your child.

## Tuition Schedule

Annual tuition is shown below.

The tuition charged by Valley Christian Schools may be paid in one of the following ways:

- Prepaid in full by July 1, 2021 (Payable directly to Valley Christian Schools):
- Payment on the 11-month plan as detailed below, starting July 2021 and ending May 2022 using FACTS, subject to credit review at VCS' option. Extra classes will be charged on a pro-rata basis.

Monthly tuition payments must be set up with FACTS for Electronic Fund Transfer (EFT) from your bank account on the 1<sup>st</sup> or 15<sup>th</sup> of each month. More information regarding your FACTS account can be found at the re-enrollment site beginning February 1, 2021. FACTS does not administer the deposit fees as these are paid online during re-enrollment. In order to reserve a space for your student, you must set up a FACTS account no later than July 1<sup>st</sup> (unless you prepay).

Please be aware that FACTS offers a "Peace of Mind" insurance policy for the very modest price of \$22.50 per year. A death in a student's family can disrupt his/her academic life due to the potential loss of educational funds. In the event of the death of the responsible party or his/her legal spouse, FACTS will pay the remaining balance up to \$30,000 (except amounts that are delinquent). Also, the Peace of Mind insurance is only available to individuals who are under the age of 70 at the time the coverage begins. There have been several situations involving deaths in the family in the past few years and we believe that this insurance policy is valuable to many families during a family hardship. We highly recommend signing up for this benefit. No other

tuition assistance will be available from the school above any amount previously granted during a hardship of this type.

### Important Re-enrollment Notice

Valley Christian Schools again will be accepting all re-enrollment and contact information online. For your convenience, the deposit may be paid by credit card or electronic check as part of the online re-enrollment. **Re-enrollment is not complete until submitted online and payment of the deposit fee is received by the Valley Christian Finance Office. Please re-enroll by February 28, 2021, to ensure your child's seat at the school is secure.**

## Additional Programs and Policies

### Miscellaneous Fees and Charges

Separate fees are charged for athletics (afterschool sports), certain electives, iPad App fees, e-textbooks, parking, scheduled busing, and other miscellaneous school activities (such as field trips). Such fees are in addition to those set forth in the schedule above. These fees are charged as incurred. Please be advised that students at the Skyway Campus also must purchase digital books, workbooks, and possibly other items as required by the course being taken.

### Skyway iPad Programs

### Youth with Promise Program

**Note: Financial Assistance must be re-applied for each year.**

The Financial Assistance application deadline will be **Monday, February 1, 2021**. The applications will be processed in the order received, so earlier submission of qualified applications will increase the likelihood of being awarded financial aid, as available funds normally run out quickly. ### Bus Service

We offer extensive bus service on selected routes in Santa Clara County at an additional charge. Busing sign-ups will be part of the online re-enrollment process available starting February 1, 2021. Free shuttle service runs continuously in the morning and afternoon from the Fehren Park and Ride lot, located approximately  $\frac{3}{4}$  of a mile north of the campus on Monterey Road. Free morning shuttle service is provided from the Ford Road Park and Ride, located approximately two miles south of the campus on Monterey Road. Times for the Ford Road shuttle service can be found on the busing website. We encourage families to take advantage of the shuttle as it serves to lessen the traffic on campus and can easily save a parent an average of 20 minutes per day picking up or dropping off their child. Please note that security is provided at the Fehren Park and Ride lot continuously each school day from approximately 6:30am to 6:45pm.

### Early Withdrawal

*In the event of early withdrawal or dismissal from VCS after May 31, 2021, for any reason, tuition already paid will NOT be refunded and tuition is still payable for the entire semester.* The school principal should be notified at least ten days in advance of the final date a student will attend school. All other non-tuition charges related to the student's enrollment must be paid up to the date of withdrawal.

### Returned Checks (NSF)

Accounts will be charged a \$30 service fee for all returned checks. After two returned checks, subsequent payments must be made by cash, cashier's check, or certified funds. Valley Christian, at its discretion, may require quarterly payments in advance for habitually delinquent accounts in order for your child to maintain attendance.

### Missed Payment Fee

A \$30 missed payment fee will be assessed by FACTS for each missed EFT payment attempt. Accounts remaining past due are reported to a credit reporting agency. A student is subject to immediate dismissal from Valley Christian Schools if their tuition account becomes 30 days past due.
