## **Complimentary Shuttle and Off-Site Student Parking Information**

### **Complimentary Shuttle Service**

Valley Christian Schools offers complimentary shuttle service at two locations, Monday through Friday on all school days. **These shuttles are available for any parent that would like to avoid the traffic on the Skyway Campus.** The first shuttle location is at the Capitol Station (Cal Trans lot) Fehren Park and Ride, located at the corner of Fehren Drive and Monterey Highway. This shuttle offers service to and from the Skyway Campus, running approximately every 15 minutes from 6:45am to 9:15am and from 2:30pm until 6:30pm. We also offer a complimentary shuttle in the **mornings only**, from the Blossom Hill Station (Cal Trans lot) Park & Ride located at the corner of Ford Road and Monterey Highway. The times for the Capitol Station Ford Shuttle are 7:15am and 7:45am. **To ensure safety, we ask that parents stay with their student in the morning until the shuttle arrives. Also, parents are asked to arrive on time to pick up their student when the shuttle returns in the afternoon (Fehren only). Please note that no supervision is provided at the shuttle stops.**

### **Complimentary Off-Site Student Parking:**

Complimentary off-site student parking is available at the Fehren Park and Ride, for all sophomores and juniors who drive to school, as well as any seniors who drive to school and choose not to pay for on-campus parking. On-campus student parking is limited to seniors only. The commitment to our neighbors during the initial development of the Skyway Campus that students are not allowed to park in the neighborhoods surrounding the campus is still in effect and must be honored. Security is provided at the Fehren Lot from 6:45am until 6:30pm.

Transportation is provided by our Campus Security for students needing a ride to their car during the shuttle off hours. It is required for all students parking at the Fehren Lot, to have a parking permit sticker for their vehicle. This can be obtained by first registering the vehicle online through the VCS Parent Portal. The permit sticker is then available through VCS Security. Off-site parking is an extension of our campus and all school rules apply while students are at the Fehren Lot.

There is to be no loitering at the Fehren Lot. Students are to immediately get on the first available bus going to Skyway and on their return they are to go directly to their cars and leave the lot. All driving safety rules will be strictly enforced by the Fehren Lot Security Officer. Any student not following the rules at Fehren Lot risks losing the privilege of using the shuttle and/or the privilege of obtaining an on-campus permit when they are a senior. It is the student's responsibility to know and follow the rules in the VCHS Student Handbook and in the Parking and Traffic Regulations.
