

## **Traffic Regulation Agreement**

Valley Christian Schools requires everyone wishing to enroll their child(ren) at Valley Christian Schools, as a condition of their enrollment, sign this TRAFFIC REGULATION AGREEMENT and provide the required vehicle and license information. If you will have a student driver, please note their grade next to their name.

These rules and regulations are necessary as a condition of minimizing traffic going up and down the Skyway hill. We have an agreement with the City of San Jose Planning Department to take the below listed measures in order to be a good neighbor as well as to minimize the traffic coming up and down the hill during peak drop off and pick up times. If traffic exceeds certain levels during peak hours, the City will require Valley Christian to take expensive traffic mitigation steps to correct and therefore the following regulations are in effect.

- Student drop off/pick up is permitted in designated areas only. The areas include the drop off area in front of the football stadium, the Ford lot (morning only, which is located south of Blossom Hill Road on Monterey Highway across from Speedee Oil Change), and the Fehren lot (located on Monterey Highway approximately  $\frac{3}{4}$  mile north of the Skyway/Monterey intersection).
- Student drop off/pick up in the neighborhood or at the entrance to the school is strictly prohibited. This is not a city ordinance, but a school rule and a condition for being in good standing with the school.
- Student parking in the neighborhood is prohibited. We have encouraged our neighbors to report any instances of students parking on neighborhood streets. Students in violation will be taken out of class, asked to relocate their cars, and may face disciplinary actions.
- Neighbors cannot authorize student parking off campus, in the neighborhood, nor on private property.
- Parking permits are required for on-campus parking and are only available to faculty, staff, and senior students. Any exception to this rule must be approved by the VCS Security Office or Transportation Office. **Parking permits are not deemed valid until they are placed on the lower left portion of the vehicles windshield.**
- Offsite parking is available at the Fehren/Monterey Park & Ride with convenient shuttle bus service available. These shuttles run continuously in the morning from 6:45am to 9:15am and in the afternoon from 2:30pm until 6:30pm. Because of the route the buses take allows them to bypass the front of the hill, the shuttle is the quickest way to get your students to school in peak traffic times. We encourage you to use the shuttle. Morning scheduled service is also available at the Ford lot. Please check the VCS website for times.

- Visitor parking is available in White Lot C located closest to the school. PLEASE NOTE THAT THERE WILL BE NO STUDENT PICK UP OR DROPS OFFS ALLOWED IN THE VISITOR LOT. Parents may enter the lot and park for school related business, but all pick-ups must be done in front of the football stadium.
- JUNIOR HIGH DISMISSAL ONLY, parents will be allowed to wait only one minute for their child in front of the football stadium before making a loop around the parking lot. It will not require going to the bottom of the hill. Our pick-ups will be much enhanced by keeping cars moving whose students are not available for pick up.
- Parents understand that violations of these regulations may be grounds for withdrawal from the School.
