GUEST PASS POLICY

The School Administrator will review all guest pass applications. If there is any question as to the authenticity of the application, the applicant will be interviewed by the School Administrator.

I am aware that my date and I must agree to the following rules before I may purchase tickets.

1. Students and guests must follow standards expected of students, in their dancing, dress code, language, and general behavior.
2. No smoking, alcoholic beverages or drugs allowed in or around this activity. No outside food or drink may be brought into the dance.
3. All students inviting guests must stay for the entire activity.
4. All students inviting guests must be responsible for acquainting the guest with rules.
- 5. *Guests must bring photo ID from their home school to gain admittance.***
6. No one will be admitted after the bus leaves Valley.
7. Parent or legal guardian must give permission for a student to leave early.
8. The student applying for a guest pass under false pretenses shall be denied the privilege of attending any Valley Christian school activity for the remainder of the school year.
9. Freaking will not be tolerated.
10. If an approved guest violates Valley Christian activity rules and regulations, he/she shall be denied future guest passes for an indefinite period and the student obtaining the guest pass shall be denied the privilege of obtaining guest passes in the future. He/she will be asked to leave the activity with no refund.
11. Guests shall not be over the age of 20. Jr. High school children are not permitted at any special high school activity. **Guests must provide picture ID at the door.**
12. Each student may receive only one guest pass per activity.

VCHS Dance Dress Code

Everyone going to the Fall Ball, (including off-campus guests), is expected to abide by the following policies.

For young ladies:

- Neck lines must be modest (be very careful of V-necks, sweetheart cuts and halters)
- Dress length and any slits should be no higher than six inches above the floor **when kneeling** with back straight (not measuring using the top of the knee). Sheer, see-through fabric is not considered when evaluating length
- No exposed midriffs or side cutouts, or cut outs in the front of the dress.
- Sheer or semi-sheer coverings are also not allowed.
- Backs must be above the waistline
- Strapless dresses are allowed if they follow all standards listed
- No bandage dresses (elasticated dresses that wrap tightly around the wearer to accentuate the profile of the body).

For young men:

- No facial hair**
- No nail polish or make-up
- Shirts must be buttoned and tucked in at all times

**Guests who do not attend Valley Christian may have facial hair, but they must abide by all other dress code policies.
